Members agreed to think about these and come back to next week's meeting to finalise the statement.

The BOT requested the original letter to the community be uploaded to BOT drive. It was agreed to spend the first half hour (from 3pm) of the next meeting to be spent on the Visioning Statement.

3.0 School Management Structure

HG spoke to the various options he had presented at last months general meeting. Feedback form the teachers had been met with a mixed response from teaching staff with approx 5 replies received.

Option A - is HG's preferred option and there was discussion on whether the person was primary or secondary. KS expressed concern that the EO position had not been included within the structures.



The BOT agreed to a management structure with 1 x DP position. This was carried unanimously. The appointment committee for the DP position needs to have the Principal, BOT Presiding Member, 1 x staff rep and at least 1 x parent rep (will be both Meret and Dan).
